

## WEST VIRGINIA HIGHER EDUCATION SYSTEM STATEWIDE COORDINATION AND LOCAL GOVERNANCE



**BOG** - Board of Governors | **BOV** - Board of Visitors

The West Virginia Higher Education Policy Commission is a coordinating body with limited oversight of state colleges and universities. West Virginia Code generally provides that the local college and university boards of governors are responsible for institutional governance, with the exception of the reviews and approvals, listed with statutory citation, below.

Since 2017 (HB 2815), Marshall, WVU and the West Virginia School of Osteopathic Medicine have been classified as "exempt" schools, which are not required to seek state-level approval of academic programs, presidents' contracts or capital projects. Prior to that, in 2005 (SB 603), Marshall and WVU were permitted to approve their own new academic programs on existing campuses and set tuition and fees up to certain limits before requiring HEPC approval. All institutions today are provided the same tuition increase threshold before requiring HEPC approval, and regional institution boards may authorize capital projects up to \$3 million.
