**BACKGROUND:** 

Pursuant to Series 5, Legislative Rule, Guidelines for Governing Boards in Employing and Evaluating Presidents, an institutional governing board must adopt a search procedure when it undertakes a search for a new President. The Commission must approve the procedure before the search begins.

During the meeting, Dr. Sarah Armstrong Tucker, Interim Chancellor, will provide an overview of the presidential search procedure as adopted by the Glenville State College Board of Governors on November 8, 2019 and for which it seeks Commission approval.

	method and process for Policy Commission members to

	adopted to govern the search, agendas, and minutes of

### WEST LIBERTY UNIVERSITY PRESIDENTIAL SEARCH PROCESS

- Search Committee established (November 2019) which includes representatives from the faculty, students, staff, and other constituencies of the institution
- Initial Search Committee meeting (November 2019)
- Elect Chair and Vice Chair of Search Committee (November 2019)
- Solicit input as to the best characteristics and qualities of the president from the institution's constituencies (faculty, staff, students)
- Approve advertisement/position statement incorporating qualities and characteristics sought in the new president, along with the timeline (November 2019)
- Advertisement will run for at least 30-60 days in Chronicle of Higher Education online edition, on HigherEdJobs.com, and in Wheeling News-Register (December/January 2020)
- Search Committee reviews applications on NEOGOV applicant tracking system (February 2020)
- Deadline to receive nominations (January 24, 2020)
- Deadline to receive applications (January 31, 2020)
- Search Committee meets to narrow the candidate pool to approximately 8 to 10 candidates (full-day meeting) (February 7, 2020)
- Search Committee hold preliminary interviews of candidates via Skype on WLU's campus or at the Highlands Center (two full-day meetings). Based on preliminary interviews, narrow the pool to the top 3 to 5 candidates to invite for on-campus interviews (February 20 & 21, 2020)
- Once the finalists are selected, conduct background checks on each candidate prior to their on-campus interviews
- Search Committee holds on-campus interviews. Each candidate will spend a day and a half on campus (start and end date may change depending on number of candidates selected) (March 16 26, 2020)
  - Breakfast Meeting with Foundation Board/Alumni Board
  - Campus Tour
  - Meet with Staff
  - Meet with Directors/Administrative Department Heads
  - Meet with Students
  - > Lunch with President's Cabinet
  - Open Meeting
  - Meet with Deans and Chairs
  - Meet with Faculty
  - Meet with President
- Search Committee, with input from the above-listed constituencies, meets to select finalists (March 27, 2020)
- Board of Governors interviews finalists for president. Higher Education Policy Commission provided opportunity to interview final candidates (April 9, 2020)
- Establish salary and terms of compensation for new president (April 9, 2020)
- Possible on-campus announcement of new president (afternoon) (April 9, 2020)
- New president takes office (July 1, 2020)
