# **Disclaimer:**

The 2020 data provided in this report are derived primarily from the Fall Census data collection. All Fall 2020 data are considered preliminary at the time of report publication and are subject to change based on final review and acceptance of campus file submissions.











### **Changes to Data Collection Methodology:**

In 2020, the Commission and Council made changes to the methodology driving the collection of student-, course- and program-level data from public two-year institutions. These changes were designed to improve our accounting of the important workforce development efforts that are a critical and integral component of a community and technical college's mission. These programs did not necessarily fit into the previous collection model, which was designed to collect data on traditional, credit-bearing academic programs and their students. Under the new model, institutions submit two sets of data files – identified as Academic and Workforce. Additional details on these files may be found later in this report. Throughout the report, you will see tables that represent data from only one of these collections, while in other cases data from both collections will be combined on a single page. To determine the source of the data represented on a given table, look for these symbols on the top-right corner of the slide:

Two File Collections – Academic and Workforce

### **Academic File Definitions**

### **Academic Program File**

 A program that is listed on the degree inventory; HLC approved; Financial aid eligible

### **Academic Courses/Registration File**

Courses and registration for academic programs only

### **Academic Student File**

 Students who are enrolled in academic programs or who are taking academic courses

### **Workforce File Definitions**

### **Workforce Program File**

 A program that is customized to meet the needs of an employer or career training; one that is not listed on the degree inventory;

### **Workforce Courses/Registration File**

Courses and registration for workforce programs only

### **Workforce Student File**

 A student who is enrolled in a workforce program or who is taking workforce courses

Under these guidelines, the same student may be reported in both file collections if they are taking both academic and workforce courses, however courses and registrations will be submitted in respective data files.


Two File Collections – Academic and Workforce

The following are **not included** in new academic or workforce file submissions:

- Internal professional development courses
- Personal enrichment courses
- Community education programs
- Programs and courses where the institution is **facilitating the enrollment for a third party** (e.g., Ed2Go or ToolingU)
  - An external organization develops the curriculum and provides the training, faculty and resources
- Programs or courses that do not use institutional funds, staff, or faculty




### **National Enrollment Trends**

### 2020-21 to 2029-30 Academic Years


According to WICHE, the number of graduates produced by public and private high schools in West Virginia will reach a **ten-year low of 16,693** in 2027.










# Academic Headcount Enrollment Age Breakdown

# Workforce Headcount Enrollment Age Breakdown








