#### Moving your HSA is simple:

- 1 Download the HealthEquity transfer form<sup>1</sup> at: HealthEquity.com/form
- 2 Complete the form entirely.

Since HSAs are individually owned accounts, only you (the account owner) can request your account be closed and the balance be transferred.

**3** Send the completed form to HealthEquity via mail, fax or email.

HealthEquity will submit the form to your prior custodian to initiate the transfer of your account balance to your TIAA HSA (less any applicable closing fees that may be assessed by your prior custodian). The transferred amount will become available in your TIAA HSA within four to six weeks (processing timeframes and blackout periods vary by custodian).
