# PCSS Course Information

### **Course Overview**

According to the PCSS Website Training Portal, the PCSS 8-hour course for Medical Students Course Overview and objectives are as follows:

Treating OUD can be difficult. Medication-Assisted Treatment (MAT) helps to normalize brain function and enables people to return to their regular lives. Expanding access to this life-saving treatment requires that all prescribers complete an 8 hour course addressing the treatment and management of patients with opioid or other substance use disorders. To address this, PCSS, in coordination with the Governor's Institute (GI), created a medical student version of the MAT waiver course that any medical professional can access free of cost.

This course consists of seven video modules and five webinars. You will receive a certificate of completion following completion of the online 8-hour MAT waiver course. This certificate will serve as documentation that you have met the 8-hour training requirement to be eligible to apply for your DEA Licenses.

### **Educational Objectives**

Below are the educational objectives outlined on in the Course Overview of the PCSS 8-hour course.

- Review the identification of opioid use disorder (OUD) and evidence-based treatments.
- Discuss the pharmacology of opioids as it relates to treatment of patients with OUD.
- Describe the fundamentals of office-based opioid treatment including the treatment of patients with co-morbid conditions.
- Explain the process of buprenorphine induction as well as stabilization and maintenance.
- Discuss other approved antagonist and agonist medications to treat OUD.
- Utilize evidence-based resources to ensure providers have the confidence to prescribe buprenorphine for patients with OUD.
- Review the appropriate use of opioids in the treatment of patients with pain and OUD.
- Recognize the importance of obtaining appropriate licensing for treating patients with OUD.




- 2. Log On

  - Then clicking, the **GET STARTED** Button.




- 5. One you have enrolled into the 8-hour Course, you will be able to access the Pretest, then course material.

# Survey/Research

### Marshall University IRB Approval Number: 1905742

### Purpose of Research

Advanced medical providers are required to complete specialized training in the treatment and management of patients with opioid or other substance use disorders. Due to recent changes in the DEA regulations, all advanced medical practitioners are required to complete the course, regardless of intention to prescribe medications for opioid use disorder (MOUD). The Health Resources Services Administration (HRSA) has determined that there are 101 Mental Health Professional Shortage Areas (MH HPSA) in WV, with 708,078 people living in a MH HPSA and only 17.36% of the need for services being met. It is estimated that an additional 122 mental health providers (typically psychiatrists) would be needed to remove the MH HPSA designations across the state. HRSA has also designated 106 Primary Care Health Professions Shortage Areas (PC HPSA) within WV with approximately 646,335 people living in those areas. HRSA estimates that 119 more primary care providers are needed to remove the shortage designation (HRSA, 2020). For reference, the 2020 population of WV is 1.74 million people (US Census Bureau, 2020).

Completing the PCSS course can be cumbersome although now essential to furthering one's medical care. It was identified in *Why aren't physicians prescribing more buprenorphine?* that lack of belief in agonist therapy is a common thread of why medical providers are resistant to treat OUD with medications (Huhn, 2017). SAMHSA partnered with Providers Clinical Support System (PCSS) to develop an online training for medical students that can be integrated into medical education to help address these identified barriers. SAMHSA awarded JCESOM a grant to integrate the PCSS training into the medical school curriculum at each of the three medical schools in WV (JCESOM, WVU SOM, WVSOM). The purpose of this research is to explore the impact of a rigorous Medication Assisted Training (MAT) curriculum on medical students' knowledge. In addition, it will explore the individual's willingness to provide treatment to those with SUD. This research will evaluate students' stigma towards SUD, their belief about the treatment of SUD, as well as the effectiveness of the PCSS training in increasing their knowledge.

### Survey Consent

You are invited to participate in a research project entitled Medical School MAT Education (MAT Ed) designed to analyze the impact of the PCSS training on medical students. The study is being conducted by Lyn O'Connell, PhD LMFT at the Joan C. Edwards School of Medicine in conjunction with Brianna Sheppard, PhD at WVU School of Medicine (WVSM) and Gretchen Lovett, PhD at the West Virginia School of Osteopathic Medicine (WVSOM). It has been approved by the Marshall University Institutional Review Board (IRB). This survey includes demographic questions and a brief survey exploring your understanding and beliefs about Substance Use. Your replies will be anonymous, so do not type your name anywhere on the form. There are no known risks involved with this study. Participation is completely voluntary and there will be no penalty or loss of benefits if you choose to not participate in this research study or to withdraw. If you choose not to participate you can leave the survey site. You may choose to not answer any question by simply leaving it blank. Once you complete the survey you can delete your browsing history for added security. Completing the on-line survey indicates your consent for use of the answers you supply. If you have any questions about the study, you may contact Lyn O'Connell at 304-691-6929.

If you have any questions concerning your rights as a research participant, you may contact the Marshall University Office of Research Integrity at (304) 696-4303. By completing this survey, you are also confirming that you are 18 years of age or older. Please print this page for your records.

As participants in the pre-survey and post- survey are voluntary and anonymous, all students will receive the email link for the pre-survey and post-survey as well as reminders to consider participation in the study. Since it is anonymous the director and research team will not know who completes the survey

# Response to Confidentially and SAMHSA Participant Protection/Human Subjects Guidelines.

Safeguarding individuals from risks associated with their participation in this project is a priority for the project team. Given the nature of this project, Marshall University (lead investigator) and partners WVU and WVSOM can address participant protection issues in general terms. The design of this project allows Marshall University and partners to determine and evaluate whether incorporating approved PCSS 8- Hour curriculum into undergraduate medical education at WV medical schools that is implemented through faculty support and statewide coordination increases 1) the number of medical school graduates with successful completion of the PCSS 8 Hour course, 2) the number of WV medical school graduates that obtain the DATA waiver to treat SUD and 3) the number of medical professionals effectively and safely prescribing medications for OUD.

### Privacy and Confidentiality

Participant information is maintained in a confidential manner in accordance with the regulations governing confidentiality 42 CFR Part 2 and HIPAA. Data collected in this study will be stored in a password protected secure application available only to the PI, PD, and project team as permitted by PI, and reported across all other stakeholders in aggregate with no personally identifying information. Students will complete course evaluations as part of normal instructional activities. Students, faculty, and staff will complete additional survey questionnaires electronically via a secure link to an anonymous survey at a time and location of their choosing while the survey link is active.

### **Consent Procedures**

As a student, you will be invited to participate in the evaluation of project objectives through the completion of anonymous survey questionnaires. IRB approval has been obtained to assess benefits, challenges, and opportunities to improve the education of SUD within the undergraduate medical school setting. The research will not pose greater than minimal risk and falls into exemption category 2 outlined in Federal Regulations for Protection of Human Research Subjects, 45 CFR 46 (surveys, interviews, educational tests and public observations that do not include children).

### What's Next?

According to the recent changes in the DEA regulations, all DEA Registrants are required to complete an 8-hour training. By completing the PCSS Online course you will have fulfilled this requirement. When applying for your DEA licenses you will have to check a box affirming that you have completed the 8-hour requirement.

### WV Specific Credentialing Information

Please note WV has not specifically addressed the change in the DEA waiver requirements.

To prescribe in WV there is specific Medicaid credentialing. Providers are recommended to become identified with Medicaid and each Managed Care Organization (MCO) as an eligible provider.

For more information regarding credentialing in WV it is recommended that you contact WV Department of Health and Human Resources, Bureau for Medical Services.

# Expectations for Faculty Champions to Support Survey Administration and Completion

Each university will be responsible for emailing each student the Pre/Post-Survey/Assessment links to complete. Completion is not required for successful completion of the PCSS Course requirements, although is encouraged in order to have the most information to interpret for the research.

### Pre-Course Completion Survey/Assessment Administration

Faculty will be required to email each of the students at least once, no more than three times to encourage completion of the pre-course completion survey. An example script is listed as Attachment 4. Each faculty team can make the determination of the frequency of the email being sent based off the setting and requirements they have set forth in completing the PCSS 8-hour Course. For example, if the course is being completed during class instruction time, one email may be sufficient. Whereas, if the course is being completed independently by the students, several emails may improve the likelihood of completion.

### Post- Course Completion Survey/Assessment Administration

Faculty will be required to email each of the students at least once, no more than three times to encourage completion of the post-course completion survey. An example script is listed as Attachment 5. Each faculty team can make the determination of the frequency of the email being sent based off the setting and requirements they have set forth in completing the PCSS 8-hour Course.
