## I. Funding Opportunity Description

### Purpose

This grant opportunity is to provide funding for institutions or campus or community-based organizations that directly serve college students. Projects will impact student mental health through one of the following strategies:

- o Peer support programming
- o Programs or environments that foster student belonging
- o Integration of mental health content and training into courses and providing content and training to various campus groups.
- o Increase mentoring opportunities
- o Implement post-mental health crisis intervention (postvention)

The opportunity is managed by the Division of Health Sciences at the West Virginia Higher Education Policy Commission and is a project of the Behavioral Health Programs Campus Mental Health initiatives designed to address mental health needs of students on West Virginia's public institutions of higher education.

### Program and Grant Opportunity Goals

Grant funds under this opportunity must be directed at improving student mental health, wellness, and safety through implementing and evaluating one or more strategies with ***promising evidence*** for impacting student mental health in higher education populations.

## **II. Award Information**

### **Opportunity Eligibility**

West Virginia public two-year and four-year institutions of higher education and campus and community-based organizations that directly serve college students are eligible to apply. ### **Summary of Funding**

Funding will be provided upon the execution of an agreement for funds. The Commission will work with the awardee to match awards with the funding available and revise budgets as needed. Requests of up to \$7,500 will be accepted for review. Up to four projects will be funded through this opportunity. The Commission will notify awardees within 6 weeks of submission. The award period will be detailed in the agreement for funds. **Funding is contingent on agency budget approval.**

### **Requirements**

Awardee will be required to adhere to the following:

1. Awardees must complete and execute an agreement for funds prior to the release of any funds. Award agreements will be sent to the signatory authority via SignNow. Only agreements signed and returned via SignNow will be accepted.
2. Awardees must invoice for grant funds. Invoicing will occur within the portal.
3. Awardees must complete a final report. Final reports will require a narrative and budget update on program activities. Reporting will occur within the portal.
4. Awardees must return any unused funds from this award at the end of the specified performance period.
5. Indirect costs are not a chargeable expense.

### **Application Submission**

Applications must be submitted via the portal.

If multiple programs at one institution are applying for Campus Mental Health Grants in any of the categories, please include the institution's ranking of the applications in narrative. Multiple Campus Mental Health applications from the same program within an institution will not be awarded.

The deadline for all Campus Mental Health Grant applications is **Tuesday, September 30, 2025, by 5:00 p.m.**

## **IV. Application Review Information**

### **Review Process**

Applications will be reviewed by Commission grants management staff (business and financial review) and program staff (technical review and analysis of proposal), as well as by a team of external content area experts.

The following criteria will be considered in the review process:

- The appropriateness of the project objectives and time frames for initiation through completion of the project.
- The reasonableness and justification for the itemized costs noted in the budget.
- The adequacy and completeness of the description of scope of services and activities to be provided with the grant funding.
- The rigor of the plan for evaluation of the project objectives.
- The potential for scalability and sustainability.

The Commission reserves the right to request revisions to the submitted proposal if, upon review, it is determined the proposed work plan does not meet the goals and requirements of this funding opportunity.
