Funding Opportunity Description

Purpose

The West Virginia Higher Education Policy Commission was awarded funds from the West Virginia Perinatal Partnership to develop and execute grant opportunities for behavioral health training programs to integrate training to prepare graduates to provide mental health care to pregnant and postpartum persons. This opportunity is made available through those funds.

This funding opportunity will support maternal mental health by providing addiction, alcohol and/or drug studies programs with funds to provide students curriculum, training, and practicum/internship experiences that focus on maternal/perinatal mental health. This helps to support the behavioral health workforce and perinatal mental health by increasing knowledge, training, and certification among current students in addiction studies programs and new behavioral health professionals across the state.

This support is made available as a one-year pilot program with the goal of evaluating effectiveness and return on investment on behalf of the participating institutions.

Program and Opportunity Goals

Applications and agreements submitted under this opportunity will meet at least one of the following goals:

- Create and expand curriculum to increase student skills in delivery of behavioral health and addiction services to the pregnant and postpartum population.
- Provide practicum and internship stipends to incentivize student placements in maternal mental health field experiences.
- Offer training required for students to qualify for the Perinatal Mental Health Certification available through Postpartum Support International (or an equivalent nationally recognized certification) to increase marketability of graduates and help fill critical shortages in West Virginia.
- Offer guest lectures from Postpartum Support International-West Virginia Chapter within current courses. Guest lectures have already been developed, and behavioral health/addiction studies programs can identify specific lectures to include in academic programming. The Commission will provide information and connect with the PSI- WV Chapter.

Deadline for submission

Applications must be submitted no later than **5:00 pm on Friday, January 30, 2026, and will be reviewed as applications are submitted.** No applications will be accepted after the deadline.

Eligibility and Funding Requirements

- An addiction studies program or behavioral health training/academic program at a public or private 2-year higher education institution in West Virginia in the fields of peer recovery, addiction studies, psychology, counseling, or social work.
- The addiction studies or behavioral health training/academic program must be an associates degree or microcredential level.

II. Award Information

Summary of Funding

The application and grant information webinars will be posted for interested public or private 4-year higher education institutions in West Virginia. Funding will be provided upon execution of an agreement for funds. A total of \$21,000 dollars is currently available for this program. Applicants can request grant funds in the amounts of \$5,000-\$7,000. Funding amounts depend on the number and quality of applications and amount requested. The Commission will work with the awardee to match awards to the funding available and revise budgets as needed. The Commission will notify awardees within 3 weeks of submission. The award period will be detailed in the agreement for funds.

Grantees must invoice for all funds prior to January 26, 2026. Grant project end dates will be December 1, 2026. Budget and narrative reports will be required 45 days after the project end date.
